WHAT IS NO-FAULT INSURANCE ?

No-fault insurance means that if you are injured or your vehicle is damaged in an accident, you can then deal with your own insurance company for coverage and compensation regardless of who is at fault.



WHAT ARE STATUTORY ACCIDENT BENEFITS ?

Statutory Accident Benefits are “no-fault” benefits that are available to you from your own insurance provider when you are involved in a motor vehicle accident. This means that no matter who was at fault in the collision, your own insurance company must pay for goods, services and other benefits provided for by the insurance policy as a result of the collision. These benefits may include but are not limited to:

- ❖ Income replacement benefits
- ❖ Caregiver benefits
- ❖ Non-earner benefits
- ❖ Medical and rehabilitation benefits
- ❖ Attendant care
- ❖ Housekeeping and home maintenance
- ❖ Expenses incurred for damaged clothing or visitor's expenses when you are in rehab
